- Call To Order** President Kourofsky called the meeting to order at 5:12 p.m. and lead the board in the pledge of allegiance.

- Clerk Pro Tem** Frank Hay moved, seconded by Earl Burnell to appoint Karen Armstrong, Clerk Pro Tem. All Board Members present voted yes—motion unanimously carried.
- Board Retreat** President Kourofsky reviewed Board of Education retreat items for consideration.
- Goals** Superintendent Amo provided the Board Members with the 2006 District Goals and Board Goals and attachments.
- Organizational Chart** Superintendent Amo provided the Board with a copy of the organizational chart. He indicated that he has met with each of the staff members in the top line. The organizational chart outlines the day to day and evaluation responsibilities of each of these staff members with the exception of the assistant principals, who will be evaluated by Mr. Amo. Mr. Amo will do direct evaluations of the staff members in the top line. He will meet with each of them four times formally. Staff members will be doing goal development. They have been holding off on goal development until district goals are established. Mr. Amo provided the administrative staff with a sample administrator evaluation form. The administrators prefer this evaluation form and they want to use it. Mr. Amo indicated that the Transportation Supervisor will report directly to him. Non-instructional staff and supervisors are reviewing draft appraisal forms. Mr. Palmer expressed a desire to see the draft appraisal forms.
- District Goals** Superintendent Amo provided some topical areas from which the District Goals may be developed. Review building safety plans, drug education, initiating or completing curriculum projects (examples: 7-12 Physical Education Curriculum or the district might want a Technology Curriculum—how do we get the training to the students to manage the world, K-8 Writing—we have selected a reading series, do we want to explore a writing

curriculum. Mr. Amo provided discussion on possible ways of getting our goals accomplished.
